- Responsible for drafting, negotiating, and executing the terms and conditions of a wide variety of agreements, primarily in the areas of industry-related research and intellectual property, to enable industry partnerships while ensuring compliance with University and Research Foundation policies.
- Responsible for coordinating with internal customers such as Principal Investigators, study staff and Technology Transfer staff, and the Office of Sponsored Projects Services to obtain technical information, budgets, protocols, and scopes-of-work for pre-award contract negotiation and execution, transitioning executed agreements to SPS for post-award activity, and utilizing and maintaining the contracts database.

The successful candidate is expected to stay apprised of evolving regulations, trends, and standards relative to technology transfer, industry sponsored research, and to incorporate those into future agreements in consultation with SUNY and Research Foundation policies. This includes utilization of internal databases related to contract maintenance.
