- **System Management:** Install, configure, and maintain PACS software systems to ensure optimal performance and reliability.
- **User Support:** Provide technical support and training to radiologists, technicians, and other medical staff on the use of the PACS system for image interpretation and diagnosis.
- **Data Security:** Implement and enforce security measures to protect patient data and ensure compliance with healthcare regulations such as HIPAA. Ensure compliance with regulatory standards set forth by state and federal agencies as well as accreditation bodies such as The Joint Commission (JTC) or the American College of Radiology (ACR).
- **Troubleshooting:** Identify and resolve technical issues related to PACS systems, including hardware failures, software glitches, and network problems.
