- Handle routine and emergency calls for service and respond to certain types of alarms.
- Work at strategic stationary posts, in order to control access and provide public safety of other assistance to the public.
- Provide for the safety of persons and property at University special events and can be called upon to assist with transportation, booking, and searching of prisoners.
- Make written reports and issue certain types of citations as necessary.
- Report security violations or hazardous conditions, and are expected to take action to correct situations or to ensure that correction takes place.
- Shift work, including night shift, weekend assignments, and special events is required.

Required Qualifications

- Must have excellent communication skills and good judgement under pressure.
- High school diploma and/or equivalent certification/experience/training.
- Applicants may be required to provide proof they have a legal right to work permanently in the United States.
- Must be 18 years of age at time of appointment.
