The Staff Research Associate serves as the principal assistant to the senior staff at Robey Lab. Under general direction of the senior staff, the Staff Research Associate performs a variety of laboratory support functions for the Robey Lab. In addition, the SRA is responsible for general office management, IT support and orientation for new undergraduates.

dimensional flow cytometry, thymic tissue slice cultures, etc.

- Maintains breeding colonies of genetically engineered strains of mice, including projecting upcoming need for particular strains of mice and adjusting the breeding cages accordingly.
- Supports maintenance of other lab members breeding colonies, including providing feedback to other lab members to improve colony efficiency.
- Involves keeping breeding records, typing mice using PCR and flow cytometry.
- Independently performs experiments to examine immune responses to Toxoplasma gondii using both in vivo and in vitro assays.
- General lab maintenance that includes preparing lab supplies, maintains equipment, job also includes general office management.
