- Provides assessment, counseling, treatment recommendations, care management, services and referrals for students with severe and persistent mental health concerns and/or who are experiencing high acuity/risk. Documents and monitors progress of individual cases. Serves on at least one high acuity team in Student Mental Health by providing services to students held by the team and participating in regular treatment planning and consultation with the team.
- Consults with senior clinicians on complex cases or on problems outside their area of expertise.
- Serves as a resource for other professional staff and training staff. May supervise training staff.
- May present psycho-educational workshops for students and academic departments.
- May provide outreach consultation to faculty and staff regarding student concerns.
- Other duties as assigned.
