Possible positions that may fall under this Maintenance/Operational temporary pool are:

- Custodian I
- Grounds Gardener I
- Maintenance Worker

The job descriptions for each job title are:

- Custodian I - This is an entry-level position involving a variety of light to heavy cleaning tasks performed independently in specific areas or as a member of a crew. Under general supervision, the employee performs tasks during the assigned shift to ensure cleanliness of assigned areas, and do related work as required.
- Grounds Gardener I - This is an entry-level position in the Grounds Gardener series involving a variety of grounds and gardening tasks performed in specific areas or as a member of a crew. Work may be assigned and supervised in such a way as to permit the performance of primarily routine duties with minimum opportunity for exercising independent judgment.
- Maintenance Worker - Under general supervision, performs both grounds maintenance and custodial duties including a variety of light to heavy custodial and cleaning tasks, or, grounds maintenance and landscape related work. Work assignments may be performed independently in specific areas or as a member of a crew.
