## **Position Summary**

The College Corps Adviser & Community Partnerships Manager supports College Corps, an exciting partnership with the state of California that funds 100 undergraduate students with \$10,000 in financial support to serve their communities. Key responsibilities are:

- 1. Advise a cohort of about 35 undergraduate Fellows; ensure they are matched with a community partner where they will serve 450 hours and that they are on track with scheduling, meeting their hours, and other program requirements.

- Advises student leaders on complex and sensitive issues.
- Brings extensive knowledge to a student generated field of interest and supports, guides and mentors students in formulating projects related to those issues.
- Guides students in interaction with campus leaders and represents students on these issues when appropriate.
- Coaches student leaders on communication and leadership skills.
- Develops and maintains relationships with internal and external organization stakeholders critical to program success, particularly the College Corps community partners and Site Supervisor designates.
- Supports returning student leaders in envisioning new ideas, recommendations, and implementing new program elements.
- Supports the creation of Pod and Homegroup curricula for College Corps Fellows that includes the exploration of community service and change making via reflection on their service and engaged learning.
- Identifies resources for student volunteer opportunities; matches student volunteers with outside public service agencies.
- Provides education, training and reflection opportunities to students engaged in public service.
- Collaborates with Public Service Center staff on staff meetings, designing and leading center wide trainings, and in staying informed of latest ideas and models in engaged, community-based learning.
