- 6. Participate in regular reviews of tickets and service requests to assure quality standards. Assist in the creation and maintenance of enrollment services standard procedures, subject protocols, and knowledge base for students and staff. Create documentation to increase knowledge sharing and document issues/solutions in a complete, concise manner for use in knowledgebase system.
- 7. Escalates unresolved situations to appropriate enrollment services staff.
- 8. Recommends needs for user training and documentation.
- 9. Participates in college wide events and trainings. Continue to update and keep technical skills current to maintain high level of product knowledge in areas of assigned responsibility.
- 10. Serves as enrollment services subject matter expert.
- 11. Performs other duties as required or as assigned.
