- Perform accessibility testing on software, apps and websites by analyzing and identifying accessibility concerns.
- Design and implement an effective and sustainable program for improving the accessibility of academic resources, with a particular focus on technology accessibility, document accessibility (including use of Anthology Ally), and media accessibility (captions, audio description).
- Develop and deliver workshops on accessible course materials and accessible digital content.
- Design and conduct training and outreach efforts to enhance awareness regarding accessibility of educational resources, digital content and universal design approaches.
- Collaborate with campus partners in advocating for accessibility in teaching technologies, course materials, websites and digital content.
- Stay abreast of emerging technologies, accessibility guidelines, relevant trends in higher education and pedagogy, and best practices and tools for accessible learning environments.
- Provide consultation to faculty in developing and selecting course materials to ensure their accessibility.
- Work to resolve issues when course materials are not accessible.
